

PROGRAM DESCRIPTION

- Students gain marketable skills with a dual focus on financial and management accounting
- Get a solid foundation in business, including communication, marketing, economics, financial statements and setting up computerized accounting systems
- Learn the management side of accounting, with skills in product costing, budgeting, price setting, eliminating financial waste and finding operating efficiencies
- Second-year students get practical experience in the student-run Loyalist College Tax Clinic. Operating under the umbrella of Canada Revenue Agency's Community Volunteer Income Tax Program, students completed 130 returns in 2013, putting more than \$150,000 back in the hands of Loyalist College students
- A three-year diploma provides advanced knowledge in taxation and auditing. The study of internal controls, audit techniques and methods to prevent fraud can lay the foundation for a career in forensic accounting, with further industry experience
